### Abstract:

Although medical tourism is an expanding segment in global tourism, medical tourism destinations are still facing complex and numerous challenges in developing, maintaining and sustaining their destinations, specifically in highly competitive environment.

- II. Insufficient information on and communication about the medical and legal risks associated with medical tourism.
- III. Inadequate policies addressing the ethical concerns of recruiting international patients in clinical trials for risky or experimental treatments.
- IV. Growing legal concerns associated with medical tourists, including malpractice lawsuits for treating international patients.
